

Information for Authors

AUTHOR RESPONSIBILITY

The author is responsible for all statements, including changes made by the copy editor. Manuscripts are received with the explicit understanding that they are not simultaneously under consideration by any other publication. All manuscripts are acknowledged upon receipt and are followed up by notification of either acceptance, revision, or rejection. Accepted manuscripts become the permanent property of the *Journal* and may not be published elsewhere without permission from the *Journal*.

Copyright. Material that is published in Connecticut Medicine is protected by copyright. In view of *The Copyright Revision Act of 1976, effective 1 January 1978*, authors of articles accepted for publication will be required to sign a statement containing the following language: "In consideration of the Connecticut State Medical Society taking action in reviewing and editing my submission entitled (here give title) the author(s) undersigned hereby transfers, assigns, or otherwise conveys all copyright ownership to the CSMS in the event that such work is published by the CSMS."

MANUSCRIPTS

All manuscripts must be submitted via email to pdumond@csms.org, and should include the following:

Cover Letter: Submissions must include a cover letter identifying the author(s), including email address(es) and biography information on author(s), mailing address(es), and telephone and fax number(s). In addition, the letter must specify the corresponding author (author responsible for negotiations concerning the manuscript), and attest that the final manuscript has been seen and approved by all authors.

First Page: Titles & Authors' Names: The first page of the manuscript must include:

- 1) Title of paper; (titles should be short, specific, clear, and amenable to indexing).
- 2) Name of author(s), including first name(s) and academic degree(s).
- 3) Hospital positions, titles, and credits for each author. If an author's present affiliation is different from the affiliation under which the work was done, both should be given. Include academic appointments when applicable. Fellowships will not be listed.
- 4) Mailing and email address(es) for all author(s)—so each may receive a copy of *Connecticut Medicine* in which their manuscript is printed and an email link to the digital edition of the *Journal*.

Abstract: The second page should contain an abstract of not more than 150 words. This abstract should be factual, not descriptive, and should present the reason for the study, the main findings (give specific data if possible), and the principal conclusion. Do not include a summary.

Manuscript: Articles must be double-spaced. Pages should be numbered, and the article, abstract, and references should be saved as one file, preferably a Microsoft Word document. Authors must follow the *American Medical Association Manual of Style* as illustrated in *JAMA* and detailed in the most recent edition of *American Medical Association Manual of Style*, compiled for the AMA and published by Williams & Wilkins.

Tables & Figures: Data presented in tables should be self-explanatory and should supplement, not duplicate, the text or figures. Excessive tabular data are discouraged. Each table should be typed, including all headings, on a separate page. Tables and figures should be numbered consecutively and indicated in parentheses when they are mentioned, (i.e., [Table 1], [Figure 1]). **Important: Figures should be separate items and saved in an eps, tif, or jpg format, minimum 300 dpi.** Legends should be included for all tables and figures.

Images & Illustrations: All supplied images should NOT be embedded within the text. Computerized drawings, graphs, charts, photographs, and scans should be **separate items** and saved in an **eps, tif or jpg format, minimum 300 dpi** for both b/w and color. Any fonts used in the image should be embedded in the file. Symbols, lettering, and numbering should be of sufficient size that when the figure is reduced to a minimum width of three inches, each item will be distinctly recognizable. **All images must be at least three inches wide.** Do not send original photographs, artwork, or black and white negatives. If photographs of patients are used, either the subjects should not be identifiable, or their pictures must be accompanied by written permission to use the figure. Legends should be included in a separate document with numbers corresponding to the illustrations/figures.

Units of Measurement: Measurements may be expressed in Système International (SI) units, but older conventional units may be included in parentheses if desired. Use Celsius for temperature.

Drug Names: Generic names should be used. Brand names may be inserted parenthetically, if desired.

References: Authors must follow *American Medical Association Manual of Style* as illustrated in *JAMA* and detailed in the most recent edition of the *American Medical Association Manual of Style*. The following minimum data should be included: names of all authors (**et als must include at least three authors**), complete title of the article cited, name of journal abbreviated according to Index Medicus, year of publication; volume number (issue): and page numbers. All references must be cited in the text. They should be arranged according to the order of citation, and not alphabetically. All references must be numbered consecutively. **If citations are not in proper order, manuscripts will be returned to authors for correction.** Numbered references to personal communications, unpublished data, and "in preparation" are unacceptable. If absolutely essential, such material may be incorporated in the appropriate place in the text or as a footnote.

Permissions: Materials taken from other sources must be accompanied by a written statement from both author and publisher giving permission to the *Journal* to reproduce such material. If clearances are required by the author's institution, statements concerning such clearance should be provided in the manuscript.

Review and Action: All manuscripts are subject to review by referees in appropriate fields of medicine. Authors are usually notified within four weeks as to the acceptability of a manuscript, but sometimes longer delays are unavoidable.
